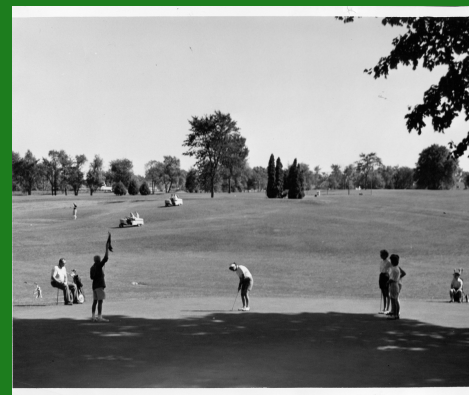

THE HISTORY

Burlington Golf Club is the oldest continuously operating golf club west of the Mississippi River, tracing its roots to 1898. The Club hired a golf pro in 1903, added a sanctioned tennis court in 1904, and hosted a 1905 Iowa State Golf Tournament. From the beginning, members appreciated the social side of their club, too! It soon took over as the community's top social center and by 1911, the Club was offering meals.

Golf remained the focus, and for decades the membership dreamed of an 18-hole course built to USGA tournament standards. That dream became a reality in 1968.

In 1992, the clubhouse expanded and remodeled from top to bottom and the Iowa Golf Association rated our course the state's best and we have only made more improvements since then!

Single members shall not have dependent children or significant others attached to their membership. A Non-Resident membership is for applicants who are 18 years or older who do not maintain a principal and primary place of residence within 10 miles of Burlington. Privileges include: pool, tennis, golf and clubhouse.

Class 14 Non-Resident Social

A Non-Resident membership is for applicants who are 18 years or older who do not maintain a principal and primary place of residence within 10 miles of Burlington. Privileges include: clubhouse.

National Membership

Age 18+

Annual Membership Dues
\$1,050

A National membership is for applicants who live 150 miles away from Burlington who do not have any type of dwelling within the area, permanent or temporary and will not be staying in the area for more than two weeks at a time. Privileges include: pool, tennis, golf and clubhouse.

Corporate

Corporate Membership Class 7 and 14

A Corporate membership is for corporation applicants doing business within the limits established by the Board. The business owning such memberships shall designate in writing to the Club the employee for whom the membership will be assigned. Before membership is issued the designated employee must submit an application to the Club and must be approved consistent with the membership process. The Business shall be liable for all dues and fees related to the membership.

Class 7 Corporate Stockholder

Privileges include: full voting rights, pool, tennis, golf, clubhouse, and the ability to hold Club office.

MEMBERSHIP

Need to Know



✓ Classification Status

All household members may use the club facilities to the extent that their classification will allow. Household members are defined as the members, their spouse or significant other, the member's and their spouse's children who are under the age of 26 and who are living in the member's home, except during the period of time that they may be away from home to attend school. Age of the oldest household member determines membership classification



✓ Food Minimum

All members with either a spouse, significant other, or dependents on their membership are required to fulfill a food minimum of \$50 monthly, with the exception of the National Membership and Non-Residents who reside outside a 25-mile radius of Burlington. Members without a spouse, significant other, or dependents on their membership are required to fulfill a \$35 monthly food minimum.

Asked Questions

Do I have to know another member before I can join?

No, The Burlington Golf Club welcomes all prospective members. Contact Tiffani White, Business Manager to discuss membership options today!

How do I get a tee time?

Tee times are preferred Friday through Sunday and on holidays. All you have to do is contact Matt Baschke, our Head Golf Professional, and he will be glad to assist you!

May I use the range if I am a Social member?

Yes! Range access is permitted to all members of the Golf Club with payment of the yearly range fee.

Does the club have an automatic service charge fee?

No. BGC does not assess an automatic service charge to members for dining. As a convenience, a 18% gratuity will be added to all tickets that go unsigned. Private use of rooms or prearranged reservations may be assessed a 20% gratuity.

How do I set up a private event?

If you are interested in setting up a private event you will just need to reach out to Cody McCoy, Clubhouse Manager, and she will be happy to help plan a party for any occasion.
