



2011 MEMBERSHIP DRIVE

In an effort to maintain that level of excellence, we are turning to the Club members to become the driving force to expand membership. The following are the details of the membership drive for 2011.

NEW MEMBERS

- Initiation fee schedule remains at reduced rates for all classes.
- Initiation fee payable in lump sum or paid in monthly installments over a period of a year.

Class 1:

- New Members shall receive \$300 Clubhouse credit (food & beverage) effective upon enrollment. Cannot be applied toward monthly assessments or minimums, must be used by October 31, 2011.
- An additional \$300 Clubhouse credit (food & beverage) beginning January 2012. Cannot be applied toward monthly assessments or minimums, must be used by October 31, 2012.

All Other Classes:

- New Members shall receive \$150 Clubhouse credit (food & beverage) effective upon enrollment. Cannot be applied toward monthly assessments or minimums, must be used by August 31, 2011.
- An additional \$150 Clubhouse credit (food & beverage) beginning January 2012. Cannot be applied toward monthly assessments or minimums, must be used by August 31, 2012.

All stockholder classes shall receive:

- Complimentary locker for 1 year for new member and spouse.
- One complimentary golf lesson for new member & spouse, to be scheduled with Joe and used in 2011
- New member receives 50% off club storage in the Pro Shop (as available)
- MGA and /or LGA dues paid for one year

Only past members that have been resigned for a period of over one year are eligible for promotion.
